#### I.4 ICOHTEC's Website: Introducing new feature – member's area

Dear Colleagues,

Let me introduce you to the new important feature of our website. In order to enhance the attractiveness of ICOHTEC membership and at the same time to fulfill numerous demands from our current members, we will provide the full access to the back issues of ICON, our peer-reviewed journal. Once logged in the member's area, you will be able to read ICON online in a form of a flipbook, or download the entire volume as a single PDF file. Both will be searchable and printable for your convenience. Each member of ICOHTEC will be provided with her/his own login and password. A new password will be generated each year and distributed to you by our treasurer. This functionality will be implemented very soon; however some additional testing is required. You can participate in it by taking a look at the Beta version available on our website.

To see how it works, go to <a href="www.icohtec.org">www.icohtec.org</a>, find the link "member area" at the top-right corner of home page, and click it. When prompted for login and password, type betatester / betatester (case sensitive). That will take you to the area, which is not visible to other internet users. On the right you will see a Control Panel, please take a minute to read the tips how it works. When the system is fully functional, you will be able to login to your account manager and modify your details.

Now to the ICON. Clicking a link labeled "Vol.1 (1995)" will take you to the page with table of contents, and the links to Flipbook and PDF version. Remember, now there is only a preview of 10 pages.

Let me add few words about the flipbook. It opens in new window. This is very convenient way to explore the back issues of our journal. All you need is Adobe Flash plugin enabled in your Internet browser. Notice a search box at the top-right corner of the window. You can search any term you need thorough the entire volume. The hits will be returned in the left side frame, and they will be highlighted in the volume on the right.

The member area is still in the phase of testing. I would appreciate any feedback, comment or bug report that would help me to improve the appearance and effectiveness of our website. Please remember to give the name and version of your internet browser, while reporting any issue.

Tip: Anytime you need to find anything particular on our website, you can use a customized google search box at top-right corner of each screen. The member area is entirely from searching by web crawlers, which prevents from entering it through the back door.

#### I.5 ICOHTEC's New Project, the "PhD Corner"

Attending the General Assemblies held during the ICOHTEC past meetings of Tampere and Glasgow, I paid attention to two items that were discussed with particular interest among several members: involvement of young scholars and visibility of the Commission.

Currently ICOHTEC is managing an active policy to incentive young scholars' work and mobility: travel support grants, book and article prizes, all advertised in ICOHTEC's Newsletter edited monthly by Stefan Poser. The excellent website, managed by Slawomir Lotysz, is an efficient channel of information to which all ICOHTEC members, and the public, can find updated news on Commission activities and its scientific proposals. Reflecting on these points, I decided to write to the Board Members to propose a project that I thought could add more to this policy. Thanks to the personal interest of the President James Williams and the positive judgment of all the Commission Officers, ICOHTEC now is starting the new initiative named the *PhD Corner*.

Aim of this project is the creation of a new page on the ICOHTEC website, an information platform that can assist in connecting young scholars and grant offers. In all the countries there are universities, archives, libraries, museums, academies and foundations that periodically offer scholarships or travel grants to finance visiting scholars to visit and use their

collections. Despite this, there is a tangible lack between *offer and demand*: graduate students and PhD candidates often find difficulties in finding the right opportunity, often because of inexperience and/or the restricted visibility in the web of many grant offers. In consideration of this reality, ICOHTEC is pleased to offer this new tool, freely available to all the user of our website.

The key of the success of a website is the quality of its contents, and the main outcome expected by the launch of this platform is to improve the visibility of the Commission among all the young scholars interested in developing experience in the field of the History of Technology.

We aim to offer information on grants offered not only in Europe and North America, but also from Latin America, the Middle East and Asia, thereby promoting real international mobility.

To realize this project we ask the cooperation of all ICOHTEC members: we are looking to collect information on any kind of grant, fellowship, travel assistance or other program for research or study offered by their working institution. This will allow ICOHTEC to promote a wide range of proposals that can meet the interests of all our members and web site users.

Members are invited to contribute to this project sending emails to my institutional address, f.gerali@igg.unam.mx, with the address of the official web page in which the grant or other offering is published to the public. As manager of the *PhD Corner* content, will be my duty organize all the information received and edit it to be published on ICOHTEC website in cooperation with our webmaster. Currently we are looking to update the page monthly, but in particular cases, such as programs with short-term deadlines, it will be possible to handle special situations.

The official beginning date of the project is February 1, 2012. *PhD Corner* page is now placed in the *Resources* section of the ICOHTEC website. In this section will be posted a list of the countries in which grant offers are available. Clicking on the selected country, the user will find a sub-list of calls for applications: each advertisement will be accompanied by a brief resume of the scientific address of the grant/program proposal. A link will address the user to the official web page of the offering institution where he/she can read the full text of offer.

We consider this initiative as an important added value to our web site and ICOHTEC mission. We would like to thank in advance all the members who will contribute information to develop the *PhD Corner*.

#### 18 April 2012

**Soldiers, Bombs and rifles. Military History of 20th Century.** A tribute to Professor Gabriel Cardona

Centre d'Estudis Històrics Internacionals de la Universitat de Barcelona CFP – Deadline **1 March 2012** 

Military History has a long tradition. For many decades, together with political History, it represented the core of historiographical approaches to 20th Century, especially the traditional ones. At the same time, for its own specific features, it was often seen as a partial and too technical branch of History, because of its contents and because of the sectors – academic and not – that produced it, and were its receivers.

The CEHI and the GRUP DE RECERCA i ANÀLISI DEL MÓN ACTUAL (GRANMA), on the other hand, believe that it is necessary to reconsider military History as an indispensable instrument to achieve a valid interpretation of contemporary age historical processes; not to isolate this branch, but to integrate it in a global approach that could consider not only the armed conflicts, but also the role that armed corps and military technology played – and keep on playing – in Contemporary History.

It is for this reason that the study day "Soldiers, bombs and rifles. Military History of 20th Century. A tribute to Professor Gabriel Cardona", because of its "generalist" approach – the analysis of the most important armed conflicts of 20th Century – and because of the prestige of the invited speakers, has been conceived to become a point of reference, that could start a productive cooperation between military History specialists, other historians and general public.

The study day (with a simultaneous interpretation service) is scheduled on April 18th, 2012, and will be divided in four thematic areas, that will lead to four sessions of conference and discussion, respectively dedicated to First World War; to military espionage as a distinctive operating form for the armed corps in 20th Century; to Second World War and, finally, to Spanish Civil War. The conferences that will structure the sessions will be held, respectively, by professors Fortunato Minniti (Università Roma Tre); Giuseppe Conti (Università La Sapienza, Rome); Allan Millet (University of New Orleans) and Joan Villarroya (Universitat de Barcelona). All of them are first-rate personalities in military History and, at the same time, authors of works of great impact, both in academia and the public in general.

La mobilité électrique est aujourd'hui étroitement associée aux déplacements individuels. La large utilisation de la motricité électrique a cependant fait suite à d'autres applications, plus anciennes. Vers 1900, l'électricité s'impose comme force motrice par l'association de différentes sociétés qui combinent la production d'électricité et l'exploitation de réseaux de transport urbain. Depuis la Première Guerre Mondiale environ, il n'est plus possible de concevoir le travail dans les mines sans l'utilisation de la force motrice électrique au niveau des transports. En revanche, les voitures électriques qui se développent dans la même période ne connaissent pas de succès durable. Parallèlement, des essais d'électrification sont menés avant la Première Guerre Mondiale dans le domaine agricole, dans la navigation maritime et bien d'autres secteurs sans se diffuser davantage. Aujourd'hui, quelques porteurs de projets testent à nouveau une assistance photovoltaïque à la propulsion des bateaux. Plus généralement, de nombreux « nouveaux » concepts et des projets pilotes d'électromobilité sont développés en lien avec les questions d'environnement et d'énergie.

Cette rencontre souhaite répondre aux questions suivantes dans une perspective francoallemande: Pourquoi certains véhicules électriques individuels ou collectifs se sont-ils imposés? Quels ont été les facteurs sociaux, techniques et économiques en jeu? Quels en ont été les acteurs? Un accent particulier sera mis sur les sources matérielles conservées par les musées de Mulhouse (Musée EDF Electropolis, Cité du train, Cité de l'automobile).

#### 3 - 5 July 2012

Geography, Science and Machines c. 1750-1960. Session at RGS-IBG 2012 University of Edinburgh

CFP - Deadline just passed 26 January 2012

This session is concerned with the role of machines within the history and geography of scientific knowledge-making c. 1750-1960. Our proposal is informed by the belief that scholarship within historical geography and the work on the geography of science has largely neglected the material and technological bases to scientific knowledge-making and to the ordering of the social world more broadly. Scholarship has been interested in the technology and instruments of exploration on earth (Driver 2001), and in outer-space (MacDonald 2007). There has been less attention, however, to historical and sociological work that emphasised the role of material infrastructure in the organisation of state power and the role of material cultural practice in the manufacture of scientific knowledge (Shapin and Schaffer 1985/2011; Callon 2004; Latour 2005; Bennett and Joyce 2010).

This proposal builds on such attempts to bridge the history of technology and the history/geography of science. We explicitly ask about the relationship between 'machines' and practices of knowledge making in the wider social and cultural contexts. We apply a broad understanding of 'machines'. They can be considered a (seemingly) independently functioning structure and a human construction and device. 'Machines' may describe 'small' instruments or 'large' technologies (mechanical systems, or electronic systems). In the attempt to avoid material determinism, we are particularly interested in studies that explore the inclusion of human design and practice into the meaning of 'machines', and that investigate the spatiality of such human-machine relationships. We especially welcome papers that explore the networks of technologies, institutions, and human practices that allow a given society to select, store and produce scientific knowledge.

Papers may include themes such as:

- The role (whether present or absent) of machines in scientific knowledge making, e.g., machines in geographical knowledge production, circulation, and reception
- Geographies of knowledge technologies (e.g., their construction, meaning, and application) and human-machine relationships
- GIS as a 'machine' and the history of GIS within (the) geographical discipline(s)
- Government/bureaucracy as machine, and machines within government/bureaucracy (office machines such as typewriters etc.)
- Spatial interaction and scalar effects of 'machines' and human practices

NeuroCultures – NeuroGenderings II

University of Vienna

CFP – Deadline 25 March 2012

Dear colleagues, we announce the conference "NeuroCultures - NeuroGenderings II" at the University of Vienna (13 - 15 September 2012) and ask for notification and circulation. Please find attached and below the CfP for this international and transdisciplinary conference.

For paper submissions, please use the online tool on our conference site neurocultures2012.univie.ac.at

Abstracts should be submitted by 25 March 2012. No conference fee for participants. We will do our best to provide travel funds, but strongly encourage participants to apply for travel funding at their home institutions.

In March 2010, participants of the international and transdisciplinary conference "NeuroGenderings" put together an expert group to critically examine research on the sexed brain. Scientists from Europe, the US, Canada and Australia from different disciplines such as neuroscience, neurocultures, the humanities, social and cultural studies, gender studies, feminist science studies, and science and technology studies, launched this network to improve reflective analysis within/of the neurosciences and to initiate dialogue across disciplinary borders. The aim of this group is to elaborate innovative theoretical and empirical approaches to address the question of sex and gender in the brain; to analyze the social and political underpinnings of the ongoing "cerebralization" of human life and especially of gender; to evaluate the current state of neuroscientific methods, evidence, and interpretations regarding sex/gender in the brain, and to discuss the impacts of neuroscientific gender research in socio-political and cultural fields.

Some of these approaches can already be read in a special issue of Neuroethics, "Neuroethics and Gender" (papers published online first available at: <a href="https://www.springerlink.com/content/120989/?Content+Status=Accepted">www.springerlink.com/content/120989/?Content+Status=Accepted</a>; the final issue will be available in late 2012).

In co-operation with the network NeuroGenderings, the Gender Research Office at the University of Vienna will launch a three-day Conference entitled "NeuroCultures – NeuroGenderings II". We aim to expand the network an invite scholars and student who engage with neuroscientific research as neuroscientists and/or brain science studies scholars with insights from the social and cultural studies of science, technology, and medicine, as well as from feminist and queer theory to discuss current developments in the field of neurocultures and gender.

#### Call for Papers

The aim of the conference "NeuroCultures – NeuroGenderings II" is to improve reflective scientific approaches concerned with sex/gender and the brain, and to gain particular insight into the transformation or persistence of gendered norms and values that accompany the

mutual entanglements between brain research, various disciplines and public discourse. With the expansion of the domains of neuroscientific knowledge, today we are witnessing an abundance of emerging neurocultures (such as neuropedagogy, neuroeconomics, neuromarketing, neurotheology, neuroaesthetics, among others) in which bio-socio-cultural relations are (re-) negotiated within research, neuro-(technological)applications, and public discourses. We use the notion of the "cerebral subject" – the cultural figure of the human according to which all we need to be ourselves is our brains (Ortega & Vidal 2007) – to describe how thought, behaviour, subjectivity and identity are collapsed with the brain's biology in these neurocultural fields. The cerebral subject is a specific kind of subject; the brain vocabulary produces a culturally and historically specific version of the human and, as such, impacts individual, social, cultural and political spheres.

Gender aspects have to be seriously taken into account within these endeavours on various levels: their empirical significance, the close entanglement of neuroscientific research with society, the impacts of neurofacts and neurotechnologies (in the broadest sense) on socio-cultural gender symbolisms and gendered power relations. Additionally, the hybrid conceptions of neurocultures have to be questioned in terms of their potentials for disrupting nature-culture dichotomies on both material and epistemological levels.

Contributions to these discussions are welcome in the following thematic strands:

- I. Empirical NeuroGenderings: Empirical research on aspects of gendering the brain including biological and socio-cultural aspects; analyses on methodological aspects and biases in the construction of sex/gender in brain research; research on the constructive processes in brain imaging, their relevance in knowledge production and in the transgression of brain concepts and findings into popular discourse; approaches from feminist and queer neuroscience in relevant fields.
- II. NeuroCultures and Brain Plasticity: Analyses of empirical research on brain plasticity, including a critical discussion of the concept itself and its impact on gender-related aspects in society; discourses on current forms of neurobiological determinism that frame all processes of thought and action explainable and predictable in terms of the brain's structures and functions, irrespective of whether these structures and functions are innate or formed by experience.
- III. Image and Politics of the Cerebral Subject: Social movements' uses of brain arguments on gender and sexuality for progressive or conservative agendas; re-politicizations of critical analyses of the cerebral subject and gender; questioning the lack of societal, political and economic situatedness and reflections of gender and intersectional categories; the cultural appeal of using the brain to account for gender and sexuality; social and political uses of brain-based arguments on sex, gender, sexuality, but also class, race, age.

IV. Power und Politics of NeuroCultures/NeuroGenderings: Emergence of a neurogovernmentality with its technologies of power and the market economy, as these are implemented into technologies of the self, where the individual brain functions as the target of control, repair and manipulation; gender dimensions of social neurosciences, neuroeconomy, neuropedagogy, neurotechnologies in general, and particularly in neuroenhancement technologies where these converge with notions of convertibility and modifiability of the brain, and are embedded in paradigms of individual optimization within modern meritocracy.

V. Transdisciplinary and NeuroGenderings: Studies on gendered brain narratives from the perspectives of history, sociology, philosophy, cultural studies, and arts; analyses of popular culture's accounts of brain and gender.

VI. Theory and Epistemology of NeuroGenderings: Theoretical and epistemological discussions about concepts as feminist materialism; approaches from gender, feminist & queer technoscience that address the fragmentations of the border between nature-culture-technology, the relations between sex, gender, and brain; other important notions/critical tools that are developed in feminist and gueer scholarship.

Internet Research 13.0 will focus on the theme of technologies, understood in the broadest sense as crafts, techniques, and systems. The conference will examine the place of the Internet in the contemporary world and in relation to a range of existing and emerging

technologies, considering its impact in a context where life is entangled with technologies of all kinds as never before. The conference will bring together scholars, researchers, students and practitioners from many disciplines to map and situate the development of the Internet as part of the history of human technology.

The International Association for the History of Transport, Traffic and Mobility (T2M) announces the call for papers to be presented at its tenth annual conference, which will take place at the Museo del Ferrocarril de Madrid (Madrid Railway Museum) on 15-18 November 2012.

#### **History and Future of Intermodal Mobilities**

Physical mobility in societies and the economic growth of societies have been linked to the availability of means of transport and to their combination and coordination, particularly as a result of modernization and urbanization processes. Intermodal processes have always been inseparable from the movement of people and goods, and in any given historical period we find testimonies and documents that verify this continual close cooperation between transport and mobility. The constant presence of these interconnection and modal transfer phenomena led to the consolidation of routes and corridors, both of intercontinental and international scope and on a national, regional and local scale. All these processes have helped to shape complex and increasingly efficient transport systems, especially since the mid-nineteenth century, coinciding with the strong impetus for technological change provided by the onset of the industrial era. Therefore, the phenomenon of intermodality did play an increasingly prominent role in transport activities, as each mode reached higher levels of speed, flexibility and technical efficiency, in stark contrast to the inertias that had existed in the characteristic transport system of the pre-industrial era.

The future of public transport in the last 100 years depended on good and easy intermodal mobility. While walking and driving may have allowed monomodal point-to-point travel, public transport by definition includes a transition between transport modes. Thus, transport planning in favour of public transport systems did face public expectation to provide intelligent intermobilities in order to support public transport modes.

The Madrid Conference seeks to analyse the processes of interconnection and integration among the different modes of transport from a historical perspective, and will therefore deal with the various aspects that converge therein: economic, social, institutional, political, technological, territorial and patrimonial. Consequently, the suggested research topics related to the concept of intermodality are the following:

• International and transnational intermodality and its technical, economic and political-administrative aspects.

- Intermodality and migratory processes.
- Intermodality in metropolitan cities and its effects on urban development and on transport demands and everyday travel habits.
- The planning of intermodal complexes throughout history: projects, successes and failures.
- Spaces for modal interchange: stations, airports, sea and river ports.
- Technological consequences for modal interchange in the sea and river transport sphere: from stowage to container traffic.
- Intermodality in the air traffic sphere. The airport within reach of the city and major intermodal hubs: from metropolitan connections to the emergence of high-speed lines.
- Light intermodality in large cities: the different ways in which users access the transport system (walking, cycling and driving to major intermodal hubs).
- Intermodality and environment.

Although we are calling for the submission of thematic session proposals, papers and posters on the subject of intermodal transport in historical perspective, the Madrid Conference would like to continue to maintain a close collaboration among academics, students and professionals engaged in research and teaching activities in all fields of historical transport, traffic and mobility studies. Therefore, any submitted paper which explores the themes that are the leitmotifs of our association will be welcomed and assessed for their possible inclusion in the conference session schedule, although papers focusing on intermodality will be afforded preferential treatment by this scientific committee.

The ASEH invites proposals for its 2013 conference that will convene 3-6 April in Toronto, Canada—North America's fourth largest city and one of the fastest growing and most ethnically and linguistically diverse places on the continent. Toronto's location, amid lakes and rivers, has long made it a site of confluences and crossings. An important aboriginal fishing site, a key portage during the fur trade, and now a "global city," the Toronto region has at different moments been a nodal point for flows of fish, furs, peoples, and capital.

Environmental history challenges many familiar boundaries. Our theme, "Confluences, Crossings, and Power" calls attention to flows and boundary-crossings, while also highlighting the role of power in shaping movements and their direction. We seek papers and panel proposals that engage with this theme in many different guises: political borders and the flows across them; the interactions of water and land; the crossings of peoples, species, and cultures; movements of pollutants across landscapes and bodies; resource and commodity flows; urban-hinterland relationships; the flows and frictions that constitute "globalization"; the crossing of intellectual boundaries; and the emergence of transdisciplinary collaborations. We also see the conference's location in Toronto as an opportunity to encourage non-US topics, transnational and comparative perspectives, and presentations focused on the Great Lakes and high-latitude regions.

#### **Submission Guidelines**

The program committee invites panel, roundtable, individual paper, and poster proposals for the conference on these and other topics. We aim to include sessions that cover the globe, all eras of history, and that engage with other important historical themes including race, gender, imperialism, and diaspora histories. We welcome teaching sessions, non-traditional formats, and sessions that encourage active audience participation. We encourage panels that include historians at different career stages and different types of institutions (academic and public) and that are gender and racially diverse. We strongly prefer to receive complete session proposals, although we will endeavor to construct sessions from proposals for individual presentations. To find possible presenters for your panel, consider posting an idea on H-Environment at least one month before the CFP deadline of June 15, 2012.

Sessions will be scheduled for 1.5 hours. Please note that it is ASEH policy to allow at least 30 minutes for discussion in every session. No single presentation should exceed 15 minutes, and each roundtable presentation should be less than ten minutes since

roundtables are designed to maximize discussion. Commentators are allowed but not required. Please note that individuals can present or comment on only one panel, roundtable, or poster session in addition to chairing a second session.
