I. ICOHTEC Prize for Young Scholars 2013

Deadline for application 23 February 2013

The ICOHTEC-Book Prize is sponsored by the Juanelo Turriano Foundation and consists of 3,000 Euro. The prize winning book will be presented and discussed at a special session of the next ICOHTEC symposium, July 2013 in Manchester UK.

ICOHTEC, the International Committee for the History of Technology, is interested in the history of technology, focusing on technological development as well as its relationship to science, society, economy, culture and the environment. The history of technology covers all periods of human history and all populated areas. There is no limitation as to theoretical or methodological approaches.

Eligible for the prize are original book-length works in any of the official ICOHTEC languages (English, French, German, Russian or Spanish) in the history of technology: published or unpublished Ph.D. theses or other monographs written by scholars who, when applying for the prize, are not older than 37 years. Articles and edited anthologies are not eligible.

For the ICOHTEC Prize 2013, please send a copy of the work you wish to be considered for the prize to each of the three Prize Committee members. Your submissions must be postmarked not later than 8 February 2013. You may also submit an electronic version of the book or Ph.D. thesis by 24:00 o'clock of your local time on the same day. If your book is in Spanish or Russian, please also supply a summary in English, French or German of about 4500 words. In that case, the prize committee will find additional members, who are familiar with the language in which your book is written.

If the work is a Ph.D. thesis, it should have been accepted by your university in 2011 or 2012; if it is a published work, the year of publication should be 2011 or 2012. The submission should be accompanied by a CV (indicating also the date of birth) and, if applicable, a list of publications. Applicants are free to add references or reviews on the work submitted.

Any materials sent to the prize committee will not be returned.

The 7th Graduate Conference in European History (GRACEH) is inviting graduate students and young researchers to reflect on the rather ambiguous relationship historians entertain with the category of "space."

We are welcoming abstracts which interrogate the various understandings of space, those which present new methodological approaches to the topic, and case studies

which are placed within a wider theoretical context. Possible topics include, but are not limited to the following:

- 1. Historians and Space: methodological and theoretical approaches
- 2. Representations of space
- 3. Going Global: linking local, regional, national, transnational history
- 4. Symbolic geography and cultural spaces: for example 'Europe', 'Central Europe', 'Central Europe', 'Central Europe', the (Delicare) the (Delicare) at a contract of the Cont
- 'Southeast Europe' or the 'Balkans', the 'Levant', the 'Orient', etc.
- 5. The spatial constitution of politics: empires and nation states (territoriality, kinship)
- 6. Economic history: world systems, 'core' and 'periphery', 'backwardness'
- 7. Spatial dimensions of everyday life: approaching gender, ethnicity, class, religion
- 8. Urban spaces (morphology, planning; spaces of production, consumption and exchange, urban/rural divides)
- 9. Geographies of knowledge: production and transfers
- 10. Space and Memory
- 11. Digital technologies and tools for writing spatial history, visualizations, Geographical Information Systems

The working language of the conference will be English. There is no participation fee and travel grants are available on a competitive basis. Please send an abstract of no more than 400 words and a brief CV to graceh[at]ceu.hu by January 20, 2013. Full papers will be pre-circulated and grouped into thematic panels of 3 to 4 contributions. We would like to ask all participants to prepare a presentation of no more than 15 minutes, in order to allow ample time for discussion and questions. Final papers are due on March 31, 2013.

Comparing China and the West: Bringing the Disciplines Together

Peking University, Beijing, China CFP – Deadline 15 January 2013

The International Association for Comparative Study of China and the West (IACSCW) invites proposals for presentations at its conference to be held in Beijing at Peking University from 12 to14 July 2013. Its primary purpose is to bring together from all over the world individuals and organizations with an ongoing interest in comparing China and the West.

Our title opens broadly to include cultural comparisons involving one or many disciplines. In particular, we want to bring together researchers with practitioners in the interest of developing new approaches to comparative studies in teaching, theory, analysis, and cultural production. Proposals for presentations are welcome from researchers in any area involving China and the West, whether academic, governmental, or corporate.

The plenary speakers will be internationally prominent scholars working on comparative issues in philosophy, translation, history, literature and other modes of cultural production. They include Professors Tang Yijie (PKU), Tu Weiming (Harvard/PKU), Jean Bessiere (Paris III), Roger Ames (Hawaii), Henry Rosemont, Jr. (Brown), and Daniel A. Bell (Tsinghua & Jiaotong).

Suggested range of topics:

- Comparative Culturology
- Problems of Translation (in either direction) and Culture Studies
- Cultural Production: today, yesterday and tomorrow
- Theoretical issues on comparing cultures and/or civilizations.
- Disciplinary debates, humanities and social sciences: China and the West
- Comparative Literary Relations
- Comparative studies of arts / dramas / films
- Comparative studies of politics and laws
- Overseas Sinology
- Comparative studies courses: pedagogical practice and theory
- Bi-national concerns: China and particular Western nations
- Contemporary issues: economics versus ecology
- Testing models for cross-cultural comparisons
- Cultural domains that resist comparison
- Funding cultural experimentation and exchange

The languages of the Association are English and Chinese. It is expected that English will be used for most conference presentations, with simultaneous interpretation provided for plenary addresses. Some panels, by prior arrangement, may take place in Chinese.

Proposals are welcome from individuals (300 words maximum) or panels involving at least three presenters (around 700 words, identifying the proposed Chairperson). Proposals must include an English version but may also include Chinese. Proposals should be submitted by using the application from the conference website under:www.chinaandthewest.org/

The relevant form can be found under Conference > Application. After filling out this two-page form using the free Adobe Reader, please email it to the organizers using the envelope icon or print and then scan to a digital copy to submit by email to: conf2013@chinaandthewest.org.

The provisional deadline for submissions is 15 January 2013. Proposals received after that date cannot be assured of equal treatment. Participants whose proposals are accepted will be expected to join the Association as full members as part of conference registration. For more detailed conference information, see our website as listed above.

The organizers intend to issue their response by late February 2013. Those who are invited to present will be notified in timely fashion of recommended hotel accommodations so that they may make their own bookings and travel arrangements.

The conference expects to charge a registration fee to cover meals and activities. In order to keep the amount modest, the Association is seeking subsidies. Hence the figure cannot be announced until closer to the conference dates.

Excellent papers presented at the conference will be selected for publishing in some European Journals which are indexed by Scopus, SCI or EI. Also the Association will invite conference papers to be submitted for consideration for its own journal: COMPARATIVE STUDIES OF CHINA AND THE WEST, whose first issue is to be distributed at the conference.

Rural History 2013 is the first conference held under the auspices of the European Rural History Organisation (EURHO). It is organised by the Swiss Rural History Society (SRHS) and the Archives of Rural History (ARH) in Bern and takes place at the University of Bern from 19-22 August 2013.

The main aim of the conference is to provide an overview of the state of the art of rural history today. Another goal is to strengthen the existing networks and co-operation of rural historians and their institutions. The conference will be an excellent occasion for historians to discuss the basic question of what exactly rural history is, how it can be narrated and, crucial for the future development of rural history, how the attractions of rural history in an era of worldwide urbanization can be communicated to the younger generation.

The conference is structured around panel sessions. The panels so far accepted by the scientific committee are now published on the website of the conference (www.ruralhistory2013.org). We invite scholars to submit their proposals for individual contributions directly to the organiser of the panel in which they would like to participate actively. It is then up to the panel organiser to decide whether she/he can accept your proposal or not. The deadline for submitting individual proposals to the panel organisers is 15 February 2013.

Panel 'Mobility of Artisans and Craftsmen' European Social Science History Conference Universität Wien, Vienna

CFP - Deadline 31 January 2013

Mobility during Early Modern period has been topic of interest for quite some time now, mostly referred to in the context of (national, transnational) supra-structures and a historical macro-level research. During the last years there has been a paradigmatic shift supporting the notion of guilds as dynamic institutions with highly mobile members.

The idea is to discuss different approaches to artisan mobility on a micro-level: Latest research shows that individuality heavily influenced artisans decisions to migrate. Furthermore mobility was an essential part of an artisans life cycle by being subject to the transformational process from apprentice to journeyman to master artisan. In order to create a forum for comparing notes on ongoing research, we are currently organising a panel on "Mobility of artisans and craftsmen" at the European Social Science History Conference in Vienna 2014, April 23rd to 26th.

The panel is open to all fields of research using social science research methods and has no regional and temporal limitations. The working language of the panel (and of the conference) will be English. It is estimated that there will between four to five presentations during the session followed by senior-comments on each of the given presentations. Therefore, we especially encourage PhD-Candidates and junior colleagues to submit their abstracts.

The proposal should be an abstract between 100 and 500 words. Please also provide your full contact details and a CV. Deadline for proposals would be January 31st 2013, since session and paper proposals will be due on May 15th 2013. The session proposal will be submitted in the section "Ethnicity and Migration".

The German Historical Institute, Washington, DC, presents the first results of his new research project Immigrant Entrepreneurship: German-American Business Biographies, 1720 to the Present.

Immigrant entrepreneurship was one of the decisive factors in the United States' rise as an economic superpower in the late nineteenth century. The country benefited from the relative openness and freedom that attracted talent from around the world and encouraged minorities who fled discrimination elsewhere to try their luck.

The collaborative research project *Immigrant Entrepreneurship: German-American Business Biographies, 1720 to the Present* explores the entrepreneurial and economic capacity of immigrants by investigating the German-American example in the United States. It traces the lives, careers, and business ventures of German-American businesspeople of roughly the last two hundred and ninety years, integrating the history of German-American immigration into the larger narrative of U.S. economic and business history. This online biographical dictionary synthesizes the results of the collaborative research project with a large collection of archival materials.
