## 1 Icohtec News

## 1.1 ICOHTEC General Assembly and Elections, Postponed to November 16th

Due to unexpected medical problems, the Icohtec General Assembly and Elections were postponed being held online in November Thursday 16<sup>th</sup>, 14:00-17:00 CET. The link will be circulated closer to the event via the membership list.

Statutes Modernization Committee will have a proposal on changes in statutes to be voted in the GA that will be held during the joint Icohtec/SHOT conference in Chile 2024.

## Nominations for candidates

The Icohtec board invites for nominations for candidates for new members in the Executive Committee elections. Self-nominations are encouraged. The names and bios of the candidates will be published on the Icohtec webpage www.icohtec.org. The vote will take place during the GA meeting on November 16<sup>th</sup>.

Three new members will be elected for a term of four years.

The function of the EC is to govern and advice the Icohtec Executive Board and its role is described in the Icohtec Statutes:

## Article 15

The Executive Committee will meet once a year, at least to the extent where the means disposed of by ICOHTEC will permit. In case it is impossible to do so, its deliberations and decisions can be carried on by correspondence. The president must carry on such consultations at least once a year. In any event the Executive Committee must meet at least once every four years before and after the General Assembly. The quorum of the Executive Committee consists of six members present or represented.

## Article 16

The Executive Committee cooperates in the preparation of and oversees the operation of the program and budgets. In the interval between the sessions of the General Assembly it makes all the decisions which circumstances require, submitting these decisions to ratification by the General Assembly.

## 1.2 Maurice Daumas Prize and Turriano Icohtec Prize Ceremonies Nov 16<sup>th</sup>

The prize ceremonies for Maurice Daumas Prize for papers and Turriano Icohtec Prize for books will be held at the beginning of the online GA on Thursday November 16<sup>th.</sup> The name of the prize winners will be announced, and they will present their award-winning studies.

## 1.3 Icohtec/SHOT 2024 in Chile

The next ICOHTEC meeting will be organized together with <u>the Society for History of Technology SHOT</u> in Viña del Mar, near Santiago de Chile, **July 8-14, 2024**: This will the first time that either society meets on the South American continent.

## 2 Conferences and Seminars

## 2.1 CFP: Industrial Heritage Conservation Symposium 2023 in Bochum, October 2023

Registration DL: October 2, 2023

## Date and place: October 19-20, 2023, Bochum, Germany

From 19 to 20 October 2023, the <u>German Mining Museum in Bochum, Germany, Leibniz Research</u> <u>Museum for Georesources</u>, will host the conference "Industrial Heritage Conservation Symposium 2023 – Good practice in the Ruhr region and Eastern Europe". The conference will deal with the practical experiences of sustainable conservation of industrial heritage.

The task of a practical conservation of industrial monuments is currently experiencing great interest. For example, the upcoming end of open-cast mining for lignite is prompting regions such as the Rhineland and Lusatia to discuss conservation and re-use perspectives. At the same time, sites of industrial heritage already are in re-use for a longer period of time, now must seek conservation solutions that are emerging for the coating of corroded and freely weathered large-scale objects. In this wave of new demands, discussions and solutions, the Industrial Heritage Conservation Symposium 2023 will provide insights, looking not only at examples in Germany but also at Hungary and Slovakia.

The conference is aimed at experts from the fields of architecture, restoration, monument conservation, historical sciences and other groups of people who are involved or interested in the conservation of industrial heritage. Participation in the conference is free of charge. Registration is required by 02 October 2023. The conference languages are German and English. However, for the German talks, no simultaneous translators are present.

# 2.2 CFP: EAUH Conference "Cities and the Environment under Twentieth Century Authoritarian Regimes"

Proposal DL: September 30, 2023.

Time and place: Ostrava, Czech Republic, 4-7 September 2024.

The European Association for Urban History (EAUH) organizes a conference with the thematic title "Cities at the Boundaries", in Ostrava, Czech Republic, 4-7 September 2024. This is a call for papers for the main session "M32 - Cities and the Environment under Twentieth Century Authoritarian Regimes".

This panel focuses on the environmental history of cities with particular focus on authoritarian regimes across the globe. The panel aims to incorporate papers analyzing the history of cities and the environment on both the political left and right starting from the Russian Revolutions until the collapse of the Soviet Union.

#### Session content

When historians of technology or the environment have investigated the environmental consequences of authoritarian regimes, they have frequently argued that authoritarian regimes have been unable to produce positive environmental results or adjust successfully to global structural change, if they have shown any concern for the environment at all. Put another way, the scholarly consensus holds that authoritarian regimes on both the left and the right generally have demonstrated an antienvironmentalist bias, and when opposed by environmentalist social movements, have succeeded in silencing those voices.

In contrast, this panel takes as its points of departure that authoritarian societies have developed environmentalist policies of their own, that environmentalism is a protean ideology, and that the sets of structures and priorities prevailing in the West represent only some of many possibilities.

The present panel aims to investigate the above-described theory on the environmental history of cities with particular focus on authoritarian regimes across the globe. This panel aims to incorporate papers analyzing the history of cities and the environment on both the political left and right starting from the Russian Revolutions until the collapse of the Soviet Union. Although the panel's chronology is linked to the existence of the USSR, its focus is not confined solely to socialist cities, rather it aims to facilitate discussion between scholars working with rightwing and leftwing authoritarian regimes across the globe from Latin America, Asia and the Pacific, Africa and Europe.

Suggested themes for individual papers include:

- Politics and the environment in authoritarian regimes
- Urban planning under authoritarian regimes (construction/destruction, new concepts) and its environmental dimension
- Authoritarian regimes, cities and economic growth (impact of industry, commerce and networks)
- Water and the city (Urban water bodies, Municipal and industrial water and wastewater)
- Consumption and waste; waste management in authoritarian regimes
- Urban space, environmental disasters and their solutions in authoritarian regimes
- War, war preparation and the urban environment
- Air quality: heating, transport, industry
- Animals in the city
- Leisure and green spaces
- Suburbanization, motorization,
- City and its surroundings: urban metabolism

Any other theme that fits the proposed methodological and chronological frame of the panel is welcome!

Histories of voice are often written as accounts of greatness: great statesmen, notable rebels, grands discourse, and famous exceptional speakers and singers populate our shelves. This focus on the great and exceptional has not only led to disproportionate attention to a small subset of historical actors (powerful, white, western men and the occasional token woman), but also obscures the broad range of vocal practices that have informed, co-created and given meaning to human lives and interactions in the past. For most historical actors, life did not consist of grand public speeches, but of private conversations, intimate whispers, hot gossip or interminable quarrels.

This volume suggests an extended practice of eavesdropping: rather than listening out for exceptional voices, it listens in on the more mundane aspects of vocality, including speech and song, but also less formalized shouts, hisses, noises and silences. Ranging from the Scottish highlands to China, from the bedroom to the platform, and from the 18th until the 20th century, contributions to this volume seek out spaces and moments that have been documented idiosyncratically or with difficulty, and where the voice and its sounds can be of particular salience. In doing so, the volume argues for a heightened attention to who speaks, and whose voices resound in history, but refuses to take the modern equation between speech and presence/representation for granted.
